

GP4PC - Privacy Policy

Our business and internal computer systems have been designed to comply with the following national and international legislation with regards to data protection and user privacy:

- UK Data Protection Act 1988 (DPA)
- EU Data Protection Directive 1995 (DPD)
- EU General Data Protection Regulation 2018 (GDPR)

What information is being collected and why?

We collect and use personal information for the following reasons:

Contacting us

Should you choose to contact us using the email or by corresponding with us by phone, e-mail, none of the data that you supply will be processed by any of the third party data processors. Any email content is kept safe on a secure email server.

The personal information you provide may include your name, address, e-mail address and telephone number as well as other information about yourself to enable us to provide you with services for the renting of property.

When you give us information about another person, you confirm that they have appointed you to act for them and to consent to the processing of their personal data.

How will we use the information about you?

We receive and store any information you provide us via email or telephone.

We use the information that you provide for such purposes as:

- To contact you.
- To provide our service to you (e.g. computer repairs, advice, invoices etc.).
- To disclose the information if required by law.

We will only ever use your personal information to respond to quotation requests and provide our computer services to you.

Who will it be shared with?

We will never sell, rent or otherwise distribute or make public your personal information. Your contact details may be passed on to our approved sub-contractors (whom have signed a data confidentiality agreement) in order for them to contact you about computer service work. If you do not wish for a sub-contractor to contact you, please make this clear on initial communication with GP4PC.

We will not share your information with any external organisations other than for the above purposes.

Where we store your personal information

The information that we collect from you is stored in a secure database that is separate to our website. The database is hosted on a UK based server. By submitting your personal information, you agree to us storing your information. We will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this privacy policy.

Your Rights

You may exercise your right to have your personal data removed from our records at any time by contacting us at privacy@gp4pc.co.uk or by the methods explained at the end of this notice.

You have a right to ask for a copy of your information and to correct any inaccuracies.

Data Breaches

We will report any unlawful data breach of the database(s) of any of our third party data processors to any and all relevant persons and authorities within 72 hours of the breach if it is apparent that personal data stored in an identifiable manner has been stolen.
